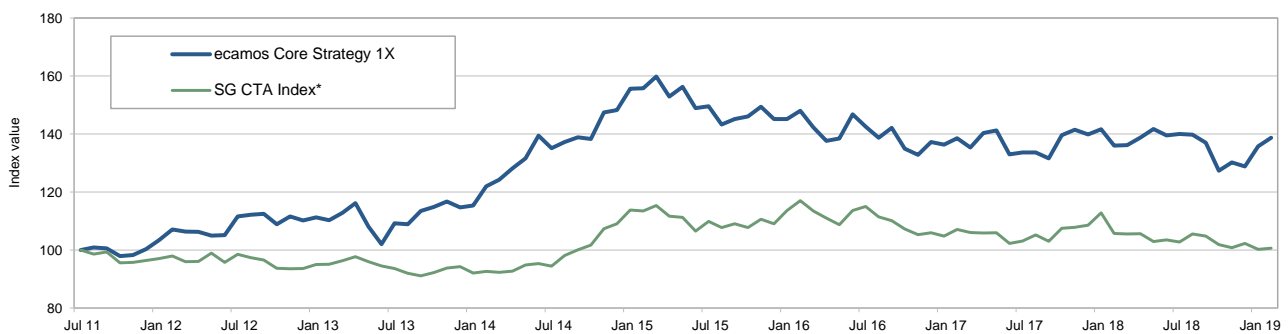
ecamos Core Strategy 1X

February 2019

Manager comment

The ecamos Core Strategy progressed in February, its 1X version closing the month at 2.16%. The SG CTA Index and the Swiss Market Index posted performances for the same period of respectively 0.42% and 4.68%. Over the last 12 months our strategy returned 1.96%, whereas the trend following index and the equity benchmark show corresponding performances of -4.67% and 5.42%. Still over the same one year time horizon, the three portfolios exhibited respective annualized volatilities of 10.62%, 5.57% and 14.32%. During the month of February, VIX CBOE futures proved to be the best performing market with a contribution of 2.70%, while VIX Option futures lay at the other end of the spectrum with an attribution of -1.01%. General risk taking, expressed by the margin to trading level ratio, increased from 16.50% to 19.72%.

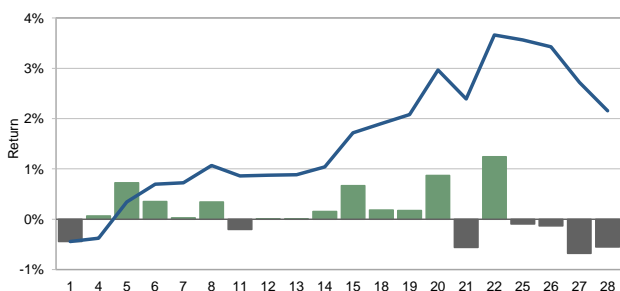

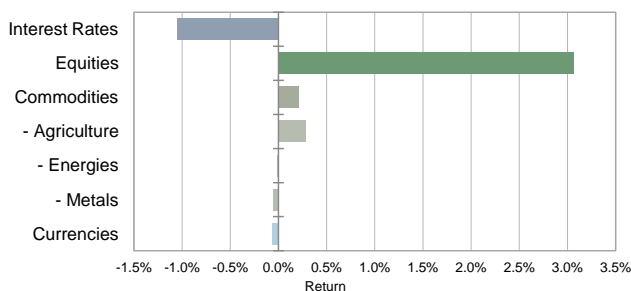

The SG CTA Index calculates the daily rate of return for a pool of CTAs selected from the largest managers that are open to new investment. Selection of the pool of qualified CTAs used in construction of the Index will be conducted annually, with re-balancing on January 1st of each year. A committee of industry professionals has been established to monitor the methodology of the index on a regular basis.

Rolling 1-year returns

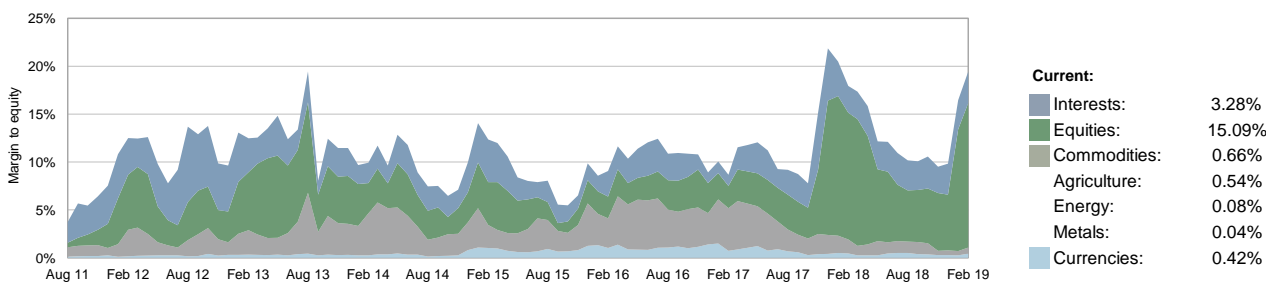

The addition of several satellite strategies further increases portfolio stability and results in a generally uncorrelated risk-return profile.
