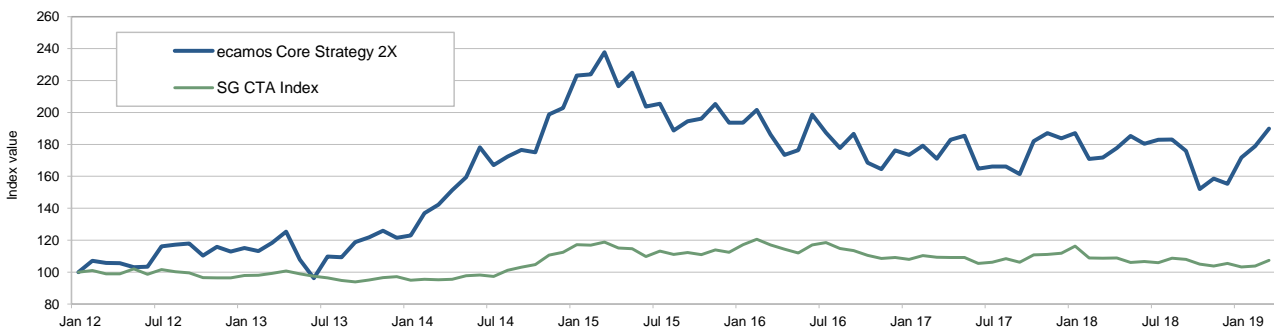
ecamos Core Strategy 2X

March 2019

Manager comment

The ecamos Core Strategy progressed in March, its 2X version closing the month at 6.10%. The SG CTA Index and the Swiss Market Index posted performances for the same period of respectively 3.44% and 0.95%. Over the last 12 months our strategy returned 10.56%, whereas the trend following index and the equity benchmark show corresponding performances of -1.25% and 8.43%. Still over the same one year time horizon, the three portfolios exhibited respective annualized volatilities of 21.34%, 6.76% and 14.08%. During the month of March, Euro German Bund futures proved to be the best performing market with a contribution of 0.74%, while Natural Gas-Henry Hub futures lay at the other end of the spectrum with an attribution of -0.43%. General risk taking, expressed by the margin to trading level ratio, decreased from 16.97% to 13.72%.

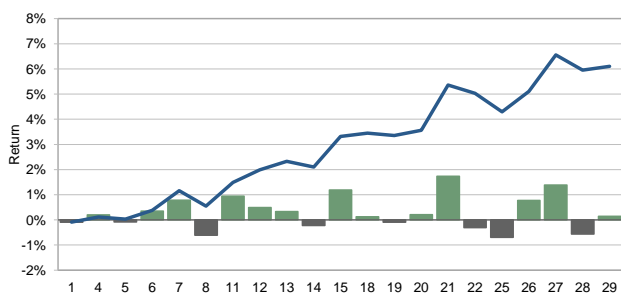

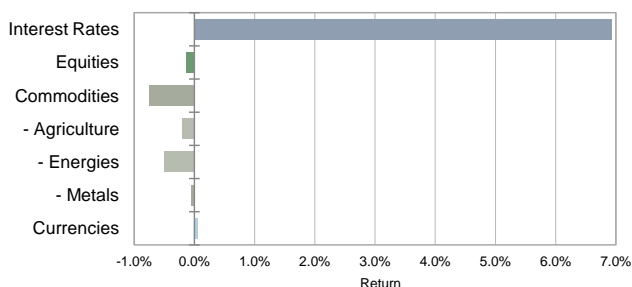
*The SG CTA Index provides the market with a reliable daily performance benchmark of major commodity trading advisors (CTAs). The SG CTA Index calculates the daily rate of return for a pool of CTAs selected from the largest managers that are open to new investment. Selection of the pool of qualified CTAs used in construction of the Index will be conducted annually, with re-balancing on January 1st of each year. A committee of industry professionals has been established to monitor the methodology of the index on a regular basis.

Rolling 1-year returns

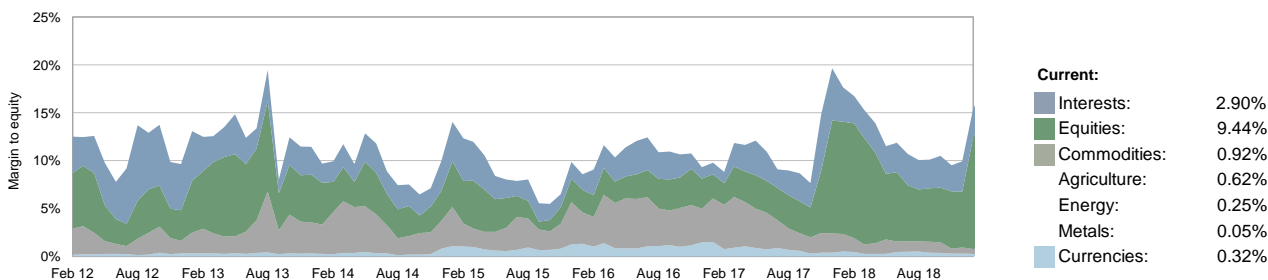

Its main driver consists of a unique model combining trend following and mean reversion into a single concept, which is implemented globally across more than 75 highly liquid futures markets spanning all asset classes (equities, interest rates, bonds, currencies and commodities). The addition of several satellite strategies further increases portfolio stability and results in a generally uncorrelated risk-return profile.
